ICE PURCHASE GUIDELINES

There are no refunds for contracted ice.

All ice must be purchased in full blocks.

Example if you are purchasing MRC ice on Saturdays you must purchase all 4 weeks. In order to receive the rate of \$12/session you must purchase a minimum of 16 sessions – you can purchase from multiple rinks.

Example: Colby Ice for 8 Sessions + MRC Ice for Saturdays both sessions – 8 sessions – totals 16 sessions

Switch Policy: All pre registered skaters are entitled to 2 swaps per contract. This is a policy to help preregistered skater who are unable to use the ice due to vacation, business trips, etc... it is not intended to use in case of illness or for last minute changes. **You must notify Kathy Carr 48 hrs prior to the session that you will be missing at [Kathy Frankcarr@yahoo.com](mailto:Kathy.Frankcarr@yahoo.com) or 207-242-5502.**

Please note if your skater is injured and you provide a doctor's note stating that the skater cannot skate due to injury with a begin and end date your missed sessions for those dates will be credited towards the next contract.
